

## DSWD DROMIC Report on the Fire Incident in Brgy. Mamhut Sur, Balasan, Iloilo

26 April 2025, 6AM

### I. Situation Overview

On 22 April 2025 at around 8 PM, a fire incident occurred in Brgy. Mamhut Sur, Balasan, Iloilo. The Bureau of Fire Protection (BFP) responded and extinguished the fire at around 9 PM. The fire gutted a house, resulting in the displacement of a family who immediately sought temporary shelter with relatives.

**One (1) family or five (5) persons** temporarily stayed with their relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Mamhut Sur, Balasan, Iloilo** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱5,756.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
