

## DSWD DROMIC Report on the Fire Incident in Brgy. Man-up, Altavas, Aklan 24 April 2025, 6AM

### I. Situation Overview

On 19 April 2025 at around 5:00 AM, a fire incident occurred in Brgy. Man-up, Altavas, Aklan. The fire was declared out at around 6:15 AM.
