

## DSWD DROMIC Report on the Fire Incident in Brgy. Mandalagan, Bacolod City 25 April 2025, 6AM

### I. Situation Overview

On 16 April 2025 at around 6:40 AM, a fire incident occurred in Brgy. Mandalagan, Bacolod City.

A total of **two (2) families** or **four (4) persons** were affected in **Brgy. Mandalagan, Bacolod City** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

A total of **two (2) families** or **four (4) persons** temporarily stayed with their relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Mandalagan, Bacolod City** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱21,580.00** worth of assistance was provided to the affected families; of which, **₱13,000.00** from **DSWD** and **₱8,580.00** from the **Local Government Unit (LGU)** (see Annex D).
