

DSWD DROMIC Report on the Fire Incident in Brgy. Manika, Libacao, Aklan

30 April 2025, 6AM

I. Situation Overview

On 24 April 2025 at around 2:00 PM, a fire incident occurred in Brgy. Manika, Libacao, Aklan. The fire was declared out at around 4:00 PM. Due to the incident, eight (8) individuals were affected resulting in significant damages to their house.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) VI, in close coordination with the Local Government Unit (LGU) of Libacao, Aklan, provided Food and Non-Food Items (FNIs) to the affected individuals.

One (1) family or **eight (8) persons** were affected in **Brgy. Manika, Libacao, Aklan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **eight (8) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Manika, Libacao, Aklan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱6,210.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
