

# **DSWD DROMIC Report on the Fire Incident in Brgy. Mansablay, Isabela, Negros Occidental**

12 April 2025, 6AM

#### I. Situation Overview

On 02 April 2025 at around 7:00 PM, a fire incident occurred at Sitio Cross, Brgy. Mansablay, Isabela, Negros Occidental.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office in Region VI, provided relief assistance to support the immediate needs of the affected family.

# IV. Damaged Houses

One (1) house was totally damaged in Brgy. Mansablay, Isabela, Negros Occidental (see Annex D).

#### V. Cost of Humanitarian Assistance Provided

A total of **₱17,496.00** worth of assistance was provided to the affected families composed of **₱7,496.00** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).


