

## DSWD DROMIC Report on the Fire Incident in Brgy. Mat-i, Las Nieves, Agusan del Norte

03 April 2025, 6PM

### I. Situation Overview

On March 8, 2025, at around 2:15 PM, a fire erupted in Brgy. Mat-i, Las Nieves, Agusan del Norte and was successfully extinguished at around 4:00 PM. As reported, the fire completely destroyed three (3) homes, displacing 3 families, equivalent to 13 individuals. Tragically, one fatality was reported in connection with the incident.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office in the Region Caraga, in coordination with the LGU of Las Nieves, promptly provided relief assistance to meet the immediate needs of the affected families and individuals.

### II. Status of Affected Areas and Population

A total of **three (3) families** or **13 persons** were affected in **Brgy. Mat-i, Las Nieves, Agusan del Norte** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

A total of **three (3) families** or **13 persons** temporarily stayed with their relatives or friends (see Annex B).

### IV. Damaged Houses

A total of **three (3) houses** were **totally damaged** in **Brgy. Mat-i, Las Nieves, Agusan del Norte** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱68,303.25** worth of assistance was provided to the affected families composed of **₱34,178.25** from **DSWD** and **₱34,125.00** from the **Local Government Unit (LGU)** (see Annex D).
