

DSWD DROMIC Report on the Fire Incident in Brgy. Nueva Vida, Mlang, North Cotabato

I. Situation Overview

On 23 April 2025 at around 10:40 AM, a fire incident occurred at Purok 1, Brgy. Nueva Vida, Mlang, North Cotabato.

II. Status of Affected Areas and Population

A total of seven (7) families or 25 persons were affected in Brgy. Nueva Vida, Mlang, North Cotabato (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **seven (7) families** or **25 persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of seven (7) houses were damaged; of which, five (5) are totally damaged and two (2) are partially damaged in Brgy. Nueva Vida, Mlang, North Cotabato (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱194,149.00** worth of assistance was provided to the affected families; of which, **₱107,585.00** from **DSWD** and **₱85,564.00** from the **Local Government Unit (LGU)** (see Annex D).
