

DSWD DROMIC Report on the Fire Incident in Brgy. Poblacion East, Bautista, Pangasinan

26 April 2025, 6PM

I. Situation Overview

On 06 April 2025 at around 2:20 PM, a fire incident occurred in Brgy. Poblacion East, Bautista, Pangasinan. Due to the incident, four individuals were affected, resulting in significant damages to their houses.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) I, together with the Local Government Unit (LGU) of Bautista, Pangasinan, provided relief assistance to address the urgent needs of the affected individuals.

II. Status of Affected Areas and Population

One (1) family or four (4) persons were affected in **Brgy. Poblacion East, Bautista, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or four (4) persons are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Poblacion East, Bautista, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱21,807.50** worth of assistance was provided to the affected families; of which, **₱21,357.50** from **DSWD** and **₱450.00** from the **Local Government Unit (LGU)** (see Annex D).
