

DSWD DROMIC Report on the Fire Incident in Brgy. Poblacion, Pikit, North Cotabato

23 April 2025, 6PM

I. Situation Overview

On 14 April 2025 at around 11:00 AM, a fire incident occurred at Purok Jasmine, Brgy. Poblacion, Pikit, North Cotabato. Due to the incident, seven (7) individuals were affected, significantly damaging their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) XII, in close coordination with Local Government Unit (LGU) of Pikit, North Cotabato, immediately provided relief assistance to address the urgent needs of the affected individuals.

One (1) family or seven (7) persons were affected in **Brgy. Poblacion, Pikit, North Cotabato** (see Annex A).

Outside Evacuation Center

One (1) family or seven (7) persons are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Poblacion, Pikit, North Cotabato** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱5,006.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
