

# DSWD DROMIC Report on the Fire Incident in Brgy. San Carlos, Anilao, Iloilo

30 April 2025, 6PM

## I. Situation Overview

On 16 April 2025 at around 9 PM, a fire incident occurred at Sitio Luawan, Brgy. San Carlos, Anilao, Iloilo. The Bureau of Fire Protection promptly responded to the scene and successfully extinguished the fire by around 10 PM. The fire completely destroyed a residential structure, resulting in the displacement of the homeowner, who has since sought temporary shelter with relatives.
