

## DSWD DROMIC Report on the Fire Incident in Brgy. Sebacauan, Isabela, Negros Occidental

10 April 2025, 6PM

### I. Situation Overview

On 25 March 2025 at around 3:00 PM, a fire incident occurred at Sitio Coyao-Coyao, Brgy. Sebacauan, Isabela, Negros Occidental.

**One (1) family or four (4) persons** were affected in **Brgy. Sebacauan in Isabela, Negros Occidental** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

**One (1) family or four (4) persons** temporarily stayed with their relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Sebacauan, Isabela, Negros Occidental** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱16,500.00** worth of assistance was provided to the affected families composed of **₱6,500.00** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
