I. Situation Overview

On 25 March 2025 at around 3:00 PM, a fire incident occurred at Sitio Coyao-Coyao, Brgy. Sebacauan, Isabela, Negros Occidental.

One (1) family or four (4) persons were affected in Brgy. Sebacauan in Isabela, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or four (4) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Sebacauan, Isabela, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱16,500.00 worth of assistance was provided to the affected families composed of ₱6,500.00 from DSWD and ₱10,000.00 from the Local Government Unit (LGU) (see Annex D).
