

DSWD DROMIC Report on the Fire Incident in Brgy. Sum-ag, Bacolod City

04 April 2025, 6AM

I. Situation Overview

On 30 March 2025 at around 10:39 AM, a fire incident occurred at Purok Santaville, Brgy. Sum-ag, Bacolod City.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) VI, in close coordination with the Local Government Unit (LGU) of Bacolod City, immediately provided food and non-food items (FNIs) to the affected family to support their immediate needs.

II. Status of Affected Areas and Population

One (1) family or **six (6) persons** were affected in **Brgy. Sum-ag, Bacolod City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **six (6) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of **one (1) house** was **totally damaged** in **Brgy. Sum-ag, Bacolod City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,790.00** worth of assistance was provided to the affected families; of which, **₱6,500.00** from **DSWD** and **₱4,290.00** from the **Local Government Unit (LGU)** (see Annex D).
