

DSWD DROMIC Report on the Fire Incident in Brgy. Tan-awan, City of Kabankalan, Negros Occidental

22 April 2025, 6PM

I. Situation Overview

On 14 April 2025 at around 5:20 PM, a fire incident occurred in Brgy. Tan-awan, City of Kabankalan, Negros Occidental. Due to the incident, seven (7) individuals were affected resulting in significant damages to their house.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) VI, in close coordination with the Local Government Unit (LGU) of City of Kabankalan, Negros Occidental, provided Food and Non-Food Items (FNIs) to the affected individuals.

One (1) family or seven (7) persons were affected in **Brgy. Tan-awan, City of Kabankalan, Negros Occidental** (see Annex A).

Outside Evacuation Center

One (1) family or seven (7) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Tan-awan, City of Kabankalan, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱6,198.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
