

## **DSWD DROMIC Report on the Inter-tribal Conflict Incident in Pasil, Kalinga**

21 April 2025, 6AM

### **I. Situation Overview**

On 08 September 2024 at around 2:30 PM, gunfire was reported at Stio Umbog which is located between the boundary of Brgy. Bagtayan and Brgy. Balatoc in Pasil, Kalinga. The following day, at approximately 12:00 PM, more gunshots were heard from the same area. Said incidents were confirmed to be linked to a longstanding inter-tribal conflict between the Balatoc and Guina-ang Tribe which led to the suspension of classes, disruption of the local farmers' and miners' livelihood, and limited mobility to access basic commodities.

In October 2024, the feuding groups, with the support of its leaders and concerned LGUs, agreed to reconcile and formally established a peace agreement.

A total of **209 families** or **909 persons** were affected in **five (5) barangays** in **Pasil, Kalinga** (see Annex A).
