

# DSWD DROMIC Terminal Report on the Armed Conflict in Northern Samar

13 April 2025, 6PM

## I. Situation Overview

On 16 March 2025 at 6:15 AM, an encounter transpired between the Philippine Army and three (3) members of the National People's Army (NPA) near Brgy. San Jose, Mapanas Northern Samar while conducting a Focused Military Operation.

Moreover, three (3) Geographically Isolated and Disadvantaged Areas (GIDA) barangays were also reported to be affected by the incident as the armed group crossed over to these barangays. As a result, a temporary lockdown was implemented in the affected areas.
