I. Situation Overview

On 30 March 2025 at around 3:00 AM, a fire incident occurred in Brgy. Baretbet, Bagabag, Nueva Vizcaya.

One (1) family or five (5) persons were affected in **Brgy. Baretbet, Bagabag, Nueva Vizcaya** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Baretbet, Bagabag, Nueva Vizcaya** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱14,667.35** worth of assistance was provided to the affected family; of which, **₱9,667.35** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
