I. Situation Overview

On 30 March 2025 at around 3:00 AM, a fire incident occurred in Brgy. Baretbet, Bagabag, Nueva Vizcaya.

One (1) family or **five (5) persons** were affected in **Brgy. Baretbet**, **Bagabag**, **Nueva Vizcaya** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **five (5) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Baretbet, Bagabag, Nueva Vizcaya** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱14,667.35 worth of assistance was provided to the affected family; of which, ₱9,667.35 from DSWD and ₱5,000.00 from the Local Government Unit (LGU) (see Annex D).
