

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Campokpok, Tabango, Leyte

20 April 2025, 6PM

I. Situation Overview

On 06 April 2025 at around 12:30 PM, a fire incident occurred in Brgy. Campokpok, Tabango, Leyte. The fire completely destroyed a house, leaving the affected family homeless. The family has since sought temporary shelter with their relatives. No injuries or casualties were reported in connection with the incident.

One (1) family or **four (4) persons** were affected in **Brgy. Campokpok, Tabango, Leyte** (see Annex A).

Outside Evacuation Center One (1) family or four (4) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Campokpok, Tabango, Leyte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱18,616.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
