

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Coliling, Rosales, Pangasinan 11 May 2025, 6PM

I. Situation Overview

On 26 March 2025 at around 3:00 PM, a fire incident occurred in Brgy. Coliling, Rosales, Pangasinan. Due to the incident, 10 individuals were affected, significantly damaging their houses.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) I, closely coordinated with the Local Government Unit (LGU) of Rosales, Pangasinan, for the distribution of relief assistance to address the urgent needs of the affected individuals. This is part of the relief augmentation support to the assistance provided by the LGU of Rosales, Pangasinan.

II. Status of Affected Areas and Population

A total of **three (3) families** or **10 persons** were affected in **Brgy. Coliling, Rosales, Pangasinan** (see Annex A).

III. Damaged Houses

A total of **three (3) houses** were damaged; of which, **two (2)** are **totally damaged** and **One (1)** is **partially damaged** in **Brgy. Coliling, Rosales, Pangasinan** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱50,048.05** worth of assistance was provided to the affected families; of which, **₱10,048.05** from **DSWD**, **₱40,000.00** from the **Local Government Unit (LGU)** (see Annex C).
