

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Guiling, Rosales, Pangasinan

13 May 2025, 6PM

## I. Situation Overview

On 02 April 2025 at around 5:00 PM, a fire incident occurred in Brgy Guiling Rosales, Pangasinan. Due to the incident, four (4) individuals were affected, significantly damaging their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) I, closely coordinated with the Local Government Unit (LGU) of Rosales, Pangasinan, to facilitate the immediate distribution of the relief assistance to address the urgent needs of the affected individuals. This is part of the relief augmentation support to the assistance provided by the LGU of Rosales, and Provincial Government of Pangasinan.

One (1) family or four (4) persons were affected in Brgy. Guiling, Rosales, Pangasinan (see Annex A).

One (1) family or 4 persons are temporarily staying with their relatives or friends (see Annex B).

## IV. Damaged Houses

One (1) house was damaged in Brgy. Guiling, Rosales, Pangasinan (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **₱16,349.35** worth of assistance was provided to the affected family; of which, **₱3,349.35** from **DSWD** and **₱13,000.00** from the **Local Government Unit (LGU)** (see Annex D).
