

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Palaypay, Basey, Samar 18 June 2025, 6AM

I. Situation Overview

On 08 April 2025 at around 1:00 AM, a fire incident occurred in Brgy. Palaypay, Basey, Samar. The fire was declared out at around 1:57 AM. Due to the incident, 11 individuals were affected and caused significant damage to their houses.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VIII, together with the Local Government Unit (LGU) of Basey, Samar, immediately provided relief assistance to address the urgent needs of the affected individuals.

II. Status of Affected Areas and Population

A total of **four (4) families** or **11 persons** were affected in **Brgy. Palaypay, Basey, Samar** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **four (4) families** or **11 persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of **four (4) houses** were damaged; of which, **three (3)** are **totally damaged** and **one (1)** is **partially damaged** in **Brgy. Palaypay, Basey, Samar** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱71,788.40** worth of assistance was provided to the affected families; composed of **₱67,788.40** from **DSWD**, and **₱4,000.00** from the **LGU** (see Annex D).
