

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. San Quintin, Alfonso Lista, Ifugao

I. Situation Overview

On 30 March 2025 at around 1:28 PM, a fire incident occurred in Brgy. San Quintin, Alfonso Lista, Ifugao. The fire was declared out at around 3:00 PM.

One (1) family or four (4) persons were affected in **Brgy. San Quintin, Alfonso Lista, Ifugao** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or four (4) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. San Quintin, Alfonso Lista, Ifugao** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱29,467.05** worth of assistance was provided to the affected family; of which, **₱9,467.05** from **DSWD**, **₱20,000.00** from the **Local Government Unit (LGU)** (see Annex D).
