

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tiblong, San Fabian, Pangasinan

15 May 2025, 6AM

### I. Situation Overview

On 06 April 2025 at around 4PM, a fire broke out in Brgy. Tiblong, San Fabian, Pangasinan. The fire completely destroyed a residential structure, displacing a family who sought temporary shelter with relatives in a nearby locality.
