

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Tubod, Iligan City, Lanao del Norte

15 April 2025, 6AM

I. Situation Overview

On 27 November 2023, a fire incident occurred at Purok Sunrice, Carbidge Village, Brgy. Tubod, Iligan City, Lanao del Norte. According to the Bureau of Fire Protection - Iligan City, the fire escalated to third alarm status at around 8:31 AM and was declared fire out at around 9:15 AM. Due to the incident, 51 individuals were affected and three (3) houses were engulfed by the fire with estimated property damage amounting to Php 635,000.00.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) X, together with the Local Government Unit (LGU) of Iligan City, Lanao del Norte, immediately provided assistance to the affected families and individuals to support their immediate needs.

II. Status of Affected Areas and Population

A total of **14 families** or **51 persons** were affected in **Brgy. Tubod, Iligan City, Lanao del Norte** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **14 families** or **51 persons** sought temporary shelter at the **Barangay Hall** in **Brgy. Tubod, Iligan City, Lanao del Norte** (see Annex B).

IV. Damaged Houses

A total of **three (3) houses** were **totally damaged** in **Brgy. Tubod, Iligan City, Lanao del Norte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱141,498.50** worth of assistance was provided to the affected families; of which, **₱119,398.50** from **DSWD** and **₱22,100.00** from the **LGU** (see Annex D).
