

# DSWD DROMIC Terminal Report on the Observance of Semana Santa 2025

05 May 2025, 6PM

# Situation Overview

As the Asian country with the highest population of Christianity, the Philippines annually commemorates the "Semana Santa" or Holy Week, a week-long celebration of Jesus Christ's sacrifice on the cross for the salvation of His people from sin and His gift of everlasting life. The observation starts on Palm Sunday and ends on Easter Sunday – the day where we celebrate Christ's resurrection from the dead. The whole week is observed in solemnity, with Holy Thursday and Good Friday declared as official holidays pursuant to Proclamation No. 727<sup>1</sup>, issued on 30 October 2024 by the Office of the President. As such, it is common that Filipinos begin to take leave from school or work as early as Holy Monday and lasting the entire week.

During this time, the majority of the Filipinos join the rush to go home to their respective hometowns and provinces to spend this holy festivity together with their families. Consequently, an increase in the volume of people is expected in transport stations such as bus terminals and air and sea ports, which amplifies their vulnerability to human-induced disasters. Naturally, we also cannot rule out the possibility of the occurrence of disasters due to natural hazards during this period.
