

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Waig, Malasiqui, Pangasinan as of 10 May 2025, 6AM

I. Situation Overview

On 24 April 2025 at around 3:00 AM, a fire incident occurred at Purok Laud, Brgy. Waig, Malasiqui, Pangasinan. Due to the incident, two (2) individuals were affected and caused significant damage to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) I, together with the Local Government Unit (LGU) of Malasiqui, Pangasinan, immediately provided relief assistance to address the urgent needs of the affected individuals.

II. Status of Affected Areas and Population

One (1) family or **two (2) persons** are affected in **Brgy. Waig, Malasiqui, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **two (2) persons** are temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Waig, Malasiqui, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱15,324.35** worth of assistance was provided to the affected family; of which, **₱11,249.35** from **DSWD** and **₱4,075.00** from the **LGU** (see Annex D).
