

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Makuguihon, Molave, Zamboanga del Sur

as of 21 May 2025, 6PM

I. Situation Overview

On 20 May 2025 at around 3:14 PM, a fire broke out at Purok Gumamela, Brgy. Makuguihon, Molave, Zamboanga del Sur. The Bureau of Fire Protection (BFP) and the Local Disaster Risk Reduction and Management Office (LDRRMO) of the Municipality of Molave promptly responded to the scene and had the fire extinguished by 3:37 PM. Several houses were destroyed, displacing numerous residents in the area who sought temporary shelter with their relatives.

II. Status of Affected Areas and Population

A total of five (5) families or 15 persons are affected in Brgy. Makuguihon, Molave, Zamboanga del Sur (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are five (5) families or 15 persons temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

A total of four (4) houses were damaged; of which, three (3) are totally damaged and one (1) is partially damaged in Brgy. Makuguihon, Molave, Zamboanga del Sur (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of \$\mathbb{P}4,432.00\$ worth of assistance was provided by \$\mathbb{DSWD}\$ to the affected families (see Annex F).
