

# DSWD DROMIC Report #1 on the Fire Incident in Brgy. Mankilam, City of Tagum, Davao del Norte as of 07 May 2025, 6PM

## I. Situation Overview

On 05 May 2025 at around 11:35 AM, a fire incident occurred at Purok Tadena, Brgy. Mankilam, City of Tagum, Davao del Norte. The fire was declared out at around 12:26 PM.

A total of **200 families** or **500 persons** are affected in **Brgy. Mankilam, City of Tagum, Davao del Norte** (see Annex A).

## III. Status of Displaced Population

### Inside Evacuation Center

There are **105 families** or **385 persons** currently taking temporary shelter at the **Brgy. Mankilam Gymnasium** in the City of **Tagum, Davao del Norte** (see Annex B).

## IV. Damaged Houses

A total of **40 houses** were **totally damaged** in **Brgy. Mankilam, City of Tagum, Davao del Norte** (see Annex C).
