

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Salvacion Habog-Habog, Molo, Iloilo City as of 30 May 2025, 6PM

I. Situation Overview

On 28 May 2025 at around 4:19 PM, a fire incident occurred in Brgy. Salvacion, Habog-Habog, Molo, Iloilo City. The fire was declared out at around 4:53 PM.

II. Status of Affected Areas and Population

A total of **eight (8) families** or **26 persons** are affected in **Brgy. Salvacion Habog-Habog, Molo, Iloilo City** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

There are **four (4) families** or **14 persons** currently taking temporary shelter in **Iloilo City National High School** in **Brgy. Salvacion Habog-Habog, Molo, Iloilo City** (see Annex B).

b. Outside Evacuation Center

There are **four (4) families** or **12 persons** temporarily staying with their relatives (see Annex C).

c. Total Displaced Population

There are **eight (8) families** or **26 persons** still displaced in **Brgy. Salvacion Habog-Habog, Molo, Iloilo City** (see Annex D).

IV. Damaged Houses

A total of **six (6) houses** were damaged; of which, **four (4)** are **totally damaged** and **two (2)** are **partially damaged** in **Brgy. Salvacion Habog-Habog, Molo, Iloilo City** (see Annex E).

V. Cost of Humanitarian Assistance Provided

A total of **₱93,393.08** worth of assistance was provided to the affected families; of which, **₱67,126.00** from **DSWD** and **₱26,267.08** from the **Local Government Unit (LGU)** (see Annex F).
