

DSWD DROMIC Report #1 on the Fire Incident in Brgy. San Roque, Santa Fe, Leyte

as of 02 June 2025, 6PM

I. Situation Overview

On 16 May 2025 at around 4:27 PM, a fire incident occurred in Brgy. San Roque, Santa Fe, Leyte. The fire was declared out at around 5:30 AM.

One (1) family or eight (8) persons are affected in Brgy. San Roque, Santa Fe, Leyte (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **eight (8) persons** are temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. San Roque, Santa Fe, Leyte (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱8,987.65** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
