

DSWD DROMIC Report #1 on the Shooting Incident in Brgy. Macabenban, Carmen, North Cotabato

as of 29 May 2025, 6PM

I. Situation Overview

On 16 May 2025 at around 5:00 AM, a shooting incident transpired between an unidentified armed group and a Maranao leader over an alleged land dispute in Brgy. Macabenban, Carmen, Cotabato Province which resulted in multiple casualties and displacement of families.

II. Status of Affected Areas and Population

A total of **1,509 families** or **7,551 persons** are affected in **Brgy. Macabenban, Carmen, North Cotabato** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **1,509 families** or **7,545 persons** currently taking temporary shelter in **four (4) evacuation centers** in **Brgy. Macabenban, Carmen, North Cotabato** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱938,598.00** worth of assistance was provided by **DSWD** to the affected families (see Annex C).
