

DSWD DROMIC Report #2 on the Fire Incident in Brgy. Malitam, Batangas City

as of 08 May 2025, 6AM

I. Situation Overview

On 27 April 2025 at around 11:43 PM, a fire incident occurred at Sitio Badjaoan, Brgy. Malitam, Batangas City. The fire was declared out on 28 April at around 2:15 AM. Due to the incident, 664 individuals were affected, significantly damaging their houses.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office CALABARZON, is closely monitoring the situation and coordinating with the Local Government Unit (LGU) of Batangas City. The DSWD FO CALABARZON is actively assisting the LGU in complying with the requirements for exceptions such as, but not limited to, the submission of a State of Calamity (SOC) declaration, in accordance with the provisions of Commission on Elections (COMELEC) Resolution No. 11060¹. However, the required SOC was not immediately submitted. Hence, the re-scheduled delivery and distribution of the food and non-food items (FNIs) on 13 May 2025.

II. Status of Affected Areas and Population

A total of **92 families** or **664 persons** are affected in **Brgy. Malitam, Batangas City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **92 families or 664 persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **92 houses** were **totally damaged** in **Brgy. Malitam, Batangas City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱118,376.00** worth of assistance was provided by the **LGU** to the affected families (see Annex D).
