

## DSWD DROMIC Report #3 on the Fire Incident in Brgy. 81, Caloocan City as of 23 May 2025, 6PM

### I. Situation Overview

On 14 May 2025 at around 4:50 PM, a fire incident occurred at B. Natividad St., Brgy. 81, Caloocan City. The fire was declared out at around 10:17 PM. Due to the incident, 810 individuals were affected and caused damage to their houses.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office National Capital Region (FO NCR), in close coordination with the Local Government Unit (LGU) of Caloocan City, immediately provided food and non-food items (FNIs) to address the urgent needs of the affected individuals.

### II. Status of Affected Areas and Population

A total of **241 families** or **810 persons** are affected in **Brgy. 81, Caloocan City** (see Annex A).

### III. Status of Displaced Population

#### Inside Evacuation Center

There are **241 families** or **810 persons** currently taking temporary shelter at **Brgy. 78 Basketball Court** in **Caloocan City** (see Annex B).

### IV. Damaged Houses

A total of **80 houses** were **totally damaged** in **Brgy. 81, Caloocan City** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱427,032.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
