

DSWD DROMIC Report #3 on the Fire Incident in Brgy. Mankilam, City of Tagum, Davao del Norte

as of 12 May 2025, 6AM

I. Situation Overview

On 05 May 2025 at around 11:35 AM, a fire incident occurred at Purok Tadena, Brgy. Mankilam, City of Tagum, Davao del Norte. The Bureau of Fire Protection (BFP). together with the City Disaster Risk Reduction and Management Office (CDRRMO) of the City Government of Tagum, promptly responded to the scene and extinguished the fire by 12:26 PM. Several houses were completely destroyed, displacing numerous families and individuals.

II. Status of Affected Areas and Population

A total of 118 families or 466 persons are affected in Brgy. Mankilam, City of Tagum, Davao del Norte (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are 118 families or 466 persons currently taking temporary shelter in two (2) evacuation centers in Brgy. Mankilam, City of Tagum, Davao del Norte (see Annex B).

IV. Damaged Houses

A total of **84 houses** were **totally damaged** in **Brgy. Mankilam, City of Tagum, Davao del Norte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱1,478,062.00 worth of assistance was provided by DSWD to the affected families (see Annex D).
