

DSWD DROMIC Report on the Armed Conflict in Brgy. Dicamay II, Jones, Isabela

13 May 2025, 6AM

I. Situation Overview

On 20 April 2025 at around 6AM, an armed conflict transpired between the government forces and the armed group of Komiteng Rehiyon Cagayan Valley (KRVC) in Brgy. Dicamay II, Jones, Isabela, resulting in the displacement of families and individuals in the area.

In response to this incident, the DSWD, through its Field Office II, swiftly provided relief assistance to address the immediate needs of the affected residents.

II. Status of Affected Areas and Population

A total of **two (2) families** or **10 persons** were affected in **Brgy. Dicamay II, Jones, Isabela** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

The **two (2) families** or **10 persons** sought temporary shelter with their relatives (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of \$\mathbb{P}3,352.70\$ worth of assistance was provided to the affected families; of which, \$\mathbb{P}1,182.70\$ from **DSWD** and \$\mathbb{P}2,070.00\$ from the **Local Government Unit** (**LGU**) (see Annex C).
