I. Situation Overview

On 20 May 2025 at around 2:19 AM, a fire incident occurred at Purok Lison, Brgy. 1 (Pob.), Bacolod City.

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. 1 (Pob.), Bacolod City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,790.00** worth of assistance was provided to the affected family; of which, **₱6,500.00** from **DSWD** and **₱4,290.00** from the **Local Government Unit (LGU)** (see Annex D).
