I. Situation Overview

On 20 May 2025 at around 2:19 AM, a fire incident occurred at Purok Lison, Brgy. 1 (Pob.), Bacolod City.

Outside Evacuation Center

One (1) family or **five (5) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. 1 (Pob.), Bacolod City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱10,790.00 worth of assistance was provided to the affected family; of which, ₱6,500.00 from DSWD and ₱4,290.00 from the Local Government Unit (LGU) (see Annex D).
