

DSWD DROMIC Report on the Fire Incident in Brgy. 23, Cagayan De Oro City, Misamis Oriental

22 May 2025, 6PM

I. Situation Overview

On 09 March 2025 at around 11 AM, a fire broke out at Zone 6 Corrales Extension, Brgy. 23, Cagayan de Oro, Misamis Oriental. The fire was declared out around 11:51 AM. A residential structure was completely destroyed. Most of the affected residents, who were renters in the building, chose to return to their respective homes. Fortunately, no injuries or casualties were reported.

A total of **13 families** or **25 persons** were affected in **Brgy. 23, Cagayan De Oro City, Misamis Oriental** (see Annex A).

III. Damaged Houses

One (1) house was reported totally damaged in Brgy. 23, Cagayan De Oro, Misamis Oriental (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of ₱138,897.00 worth of assistance was provided to the affected families; of which, ₱111,268.00 from DSWD and ₱27,629.00 from the Local Government Unit (LGU) (see Annex C).
