

DSWD DROMIC Report on the Fire Incident in Brgy. Bagalay, Tayum, Abra

04 May 2025, 6PM

I. Situation Overview

On 14 March 2025 at around 9:30 AM, a fire incident occurred at Sitio Pitao, Brgy. Bagalay, Tayum, Abra. Local residents attempted to suppress the fire, but their efforts were unsuccessful. During the incident, one (1) individual sustained burns to the face and injuries to the hands. He received immediate first aid from both responding residents and officials from the Rural Health Unit.

The fire completely destroyed a residential structure, resulting in the displacement of the affected family. They have since sought temporary shelter with relatives while awaiting the construction of their new home.

II. Status of Affected Areas and Population

One (1) family or **two (2) persons** were affected in **Brgy. Bagalay, Tayum, Abra** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or two (2) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Bagalay, Tayum, Abra** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱69,691.60** worth of assistance was provided to the affected family; of which, **₱39,691.60** from **DSWD** and **₱30,000.00** from the **Local Government Unit (LGU)** (see Annex D).
