

## DSWD DROMIC Report on the Fire Incident in Brgy. Bata, Bacolod City 25 May 2025, 6AM

### I. Situation Overview

On 20 May 2025 at around 8:00 AM, a fire incident occurred in Brgy. Bata, Bacolod City.

#### Outside Evacuation Center

**One (1) family** or **four (4) persons** temporarily stayed with their relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Bata, Bacolod City** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱10,790.00** worth of assistance was provided to the affected family; of which, **₱6,500.00** from **DSWD** and **₱4,290.00** from the **Local Government Unit (LGU)** (see Annex D).
