I. Situation Overview

On 17 May 2025 at around 8:30 AM, a fire incident occurred in Brgy. Bula, Mambusao, Capiz. The fire was declared out at around 9:00 AM.

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

One (1) house was totally damaged in Brgy. Bula, Mambusao, Capiz (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P7,377.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
