

DSWD DROMIC Report on the Fire Incident in Brgy. Cansalongon, Isabela, Negros Occidental

30 May 2025, 6AM

I. Situation Overview

On 19 May 2025 at around 11 PM, a fire broke out in Brgy. Cansalongon, Isabela, Negros Occidental. The fire completely destroyed a residential structure, displacing a family who has since sought temporary shelter with relatives.

One (1) family or six (6) persons were affected in Brgy. Cansalongon, Isabela, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **six (6) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Cansalongon, Isabela, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱6,220.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
