

## **DSWD DROMIC Report on the Fire Incident in Brgy. Guinzadan Central, Bauko, Mountain Province**

03 May 2025, 6PM

### **I. Situation Overview**

On 01 March 2025 at around 10:48 AM, a fire incident occurred at Sitio Caotit, Brgy. Guinzadan Central, Bauko, Mountain Province. The fire partially damaged a residential structure and resulted in one (1) casualty. The victim sustained burn injuries on multiple parts of his body.
