

DSWD DROMIC Report on the Fire Incident in Brgy. Guinzadan Central, Bauko, Mountain Province

03 May 2025, 6PM

I. Situation Overview

On 01 March 2025 at around 10:48 AM, a fire incident occurred at Sitio Caotit, Brgy. Guinzadan Central, Bauko, Mountain Province. The fire partially damaged a residential structure and resulted in one (1) casualty. The victim sustained burn injuries on multiple parts of his body.

One (1) family or **three (3) persons** were affected in **Brgy. Guinzadan Central**, **Bauko, Mountain Province** (see Annex A).

III. Damaged Houses

One (1) house was partially damaged in **Brgy. Guinzadan Central, Bauko, Mountain Province** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱20,750.00** worth of assistance was provided to the affected family; of which, **₱18,550.00** from **DSWD** and **₱2,200.00** from the **Local Government Unit (LGU)** (see Annex C).
