I. Situation Overview

On 06 May 2025 at around 4:00 PM, a fire occurred in Brgy. Hilamonan, Kabankalan City, Negros Occidental.

One (1) family or seven (7) persons were affected in Brgy. Hilamonan, Kabankalan City, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **seven (7) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Hilamonan, Kabankalan City, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱6,688.00 worth of assistance was provided to the affected family; of which, ₱4,588.00 from DSWD and ₱2,100.00 from the Local Government Unit (LGU) (see Annex D).
