

DSWD DROMIC Report on the Fire Incident in Brgy. Jubgan, San Francisco (Anao-aon), Surigao del Norte

I. Situation Overview

On 09 May 2025 at around 9AM, a fire broke out at Purok 2, Brgy. Jubgan, San Francisco (Anao-aon), Surigao del Norte. The Bureau of Fire Protection (BFP) promptly responded to the scene and extinguished the fire by 10:55 AM. A residential structure was completely destroyed, displacing one family. No injuries or casualties were reported.

II. Status of Affected Areas and Population

One (1) family or four (4) persons were affected in Brgy. Jubgan, San Francisco (Anao-aon), Surigao del Norte (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or four (4) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Jubgan, San Francisco (Anao-aon), Surigao del Norte (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,681.50** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
