

DSWD DROMIC Report on the Fire Incident in Brgy. Kirang, Aritao, Nueva Vizcaya

04 May 2025, 6PM

I. Situation Overview

On 15 April 2025 at around 10:42 AM, a fire incident occurred in Brgy. Kirang, Aritao, Nueva Vizcaya. The fire completely engulfed a house, displacing a family that is still seeking temporary shelter with relatives.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office in Region II, provided relief assistance to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or two (2) persons were affected in **Brgy. Kirang, Aritao, Nueva Vizcaya** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or two (2) persons are temporarily staying with relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Kirang, Aritao, Nueva Vizcaya** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱24,445.18** worth of assistance was provided to the affected family; of which, **₱5,073.26** from **DSWD**, **₱10,500.00** from the **Local Government Unit (LGU)**, and **₱8,871.92** from **other partners** (see Annex D).
