

DSWD DROMIC Report on the Fire Incident in Brgy. Kumao, Kabugao, Apayao

18 May 2025, 6AM

I. Situation Overview

On 23 March 2025 at around 2:00 AM, a fire incident occurred at Sitio Madgay, Brgy. Kumao, Kabugao, Apayao. Due to the incident, 10 individuals were affected and caused significant damage to their house.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) Cordillera Administrative Region (CAR), in coordination with the Local Government Unit (LGU) of Kabugao, Apayao, promptly provided relief assistance to support the immediate needs of the affected individuals.

A total of **two (2) families** or **10 persons** were affected in **Brgy. Kumao, Kabugao, Apayao** (see Annex A).

One (1) house was totally damaged in Brgy. Kumao, Kabugao, Apayao (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱39,117.50** worth of assistance was provided by **DSWD** to the affected families (see Annex C).
