I. Situation Overview

On 02 March 2025 at around 2:35 AM, a fire incident occurred in Brgy. Lagben, Lagangilang, Abra. The fire was declared out at around 4:00 AM.

One (1) person temporarily stayed with his relatives (see Annex B).

One (1) house was totally damaged in **Brgy. Lagben, Lagangilang, Abra** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱41,166.70** worth of assistance was provided to the affected person; of which, **₱36,166.70** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
